



COMPETITION TERMS AND CONDITIONS

§1 General Provisions

1. The Competition is organised by Międzynarodowy Port Lotniczy im. Jana Pawła II Kraków-Balice sp. z o.o. with its registered office in Balice, ul. kpt. M. Medweckiego 1, entered into the Register of Entrepreneurs under KRS number: 0000008522 (records kept by the District Court for Kraków-Śródmieście in Kraków, 12th Commercial Division of the National Court Register), NIP (Taxpayer Identification Number): 676-13-36-952, REGON (National Business Register Number): 351117055, with a share capital of PLN 101,232,000.00, hereinafter referred to as Kraków Airport.
2. The Competition is only organised for natural persons (Participant) who are members of the Kraków Airport Loyalty Programme and who:
 - a) are adult;
 - b) are consumers within the meaning of Article 22¹ of the Civil Code of 23 April 1964 (consolidated text: Journal of Laws Dz. U. of 2018, Item 1025 as amended);
 - c) have full legal capacity to perform acts in law, with the stipulation that persons with restricted legal capacity participate in the Competition with the consent of their statutory representative or guardian;
 - d) are not employees of Kraków Airport and other entities directly involved in preparing and conducting the Competition, as well as their family members and persons in cohabitation with them;
 - e) provide their real contact details, i.e. name, surname, email address and, should they win the Prize, details required to deliver it.
3. By entering the Competition, the Participant is obliged to comply with the Kraków Airport Loyalty terms and conditions under penalty of being excluded from the Competition.

§2 Provisions Regarding Entries

1. The Participants of the Competition are tasked with providing correct answer to question **“How many new connections have been announced so far for the SUMMER 2019 season from/to Kraków Airport? (as of 20/12/2018).**
2. The answers should be sent to the email address konkurs.KAL@krakowairport.pl with the subject “Christmas competition”.
3. Should the Participant violate the applicable law or attempt fraud, Kraków Airport reserves the right to exclude their entry from the competition process.
4. By submitting their entry and participating in the Competition the Participant accepts the Terms and conditions.

§3 Personal Data Protection

1. By entering the Competition, the Participants agree to the processing of their personal data for the purposes of the Competition, selecting and announcing winners, awarding prizes, issuing, collecting and settling prizes and for marketing purposes by Kraków Airport in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), OJ L 119, 04.05.2016 (hereinafter referred to as GDPR).
2. Kraków Airport only collects data that is necessary to properly conduct the Competition, send out prizes, and for marketing purposes during and after the Competition.
3. The Participant confirms that data submitted to Kraków Airport is true and correct.
4. The database that contains the Participants' personal data and information is temporary in nature and shall be deleted immediately after its use, i.e. upon sending prizes to the Participants. Data and information referred to in the first sentence is sensitive and protected against access by unauthorized persons.
5. Kraków Airport will not share the Participants' personal data with any other third parties without a legal basis compelling Kraków Airport to do so. Kraków Airport will make every effort to ensure that the information is properly protected, and particularly in the manner provided for by the GDPR.
6. Kraków Airport enables the Participants to exercise their rights resulting from the GDPR. In particular, the Participant has the right to view and correct their personal data as well as demand their removal.

§4 Schedule

1. The answers should be sent **until 26 December 2018 at 23:59**.
2. The first 5 participants to send the correct answers will win.
3. Winners will be informed of the results by email sent to the address provided upon submission.
4. Should the Winner not meet the provisions set out in the Terms and conditions, they will lose the right to the prize. If the fact is revealed after its delivery, they will be required to return it. Kraków Airport reserves the right to award such a prize to another Participant who meet the provisions set out in the Regulations.

§5 Prizes

1. The Competition offers as a prize a set of Kraków Airport calendars.
2. One person may only win one Prize.
3. Prizes cannot be exchanged for cash or any other prize.
4. The Participant cannot transfer the right to the Prize onto any third parties.
5. The Participant may relinquish the Prize.

6. Kraków Airport is not responsible for incorrect or false address of residence or other information provided by the Participant that would prevent or delay the delivery of prizes by Kraków Airport in connection with the Competition.

§6 Claims and Complaints

1. Any claims arising out of the Competition – provided that they have not expired under the terms of a specific provision of the Terms and conditions – must be submitted to Kraków Airport within 3 days following the end of the Competition, otherwise they will expire.
2. The Participant of the Competition may inform Kraków Airport of any irregularities related to the Competition.
3. The Participant of the Competition has the right to submit complaints related to the course of the Competition to the following address: konkurs.KAL@krakowairport.pl.
4. Complaints shall be reviewed by Kraków Airport within 3 calendar days from the date of their receipt. Kraków Airport will review complaints based on the Terms and conditions. The decision made by Kraków Airport shall be communicated to the Participant by an email sent to the address provided by the Participant.

§7 Final Provisions

1. By entering the Competition, the Participant accepts the Terms and conditions.
2. Kraków Airport reserves the right to change the Terms and conditions as long as the change does not negatively impact the conditions of participation in the Competition. This particularly applies to changes in the schedule of individual activities within the Competition and prize specification.
3. Changes to the Terms and conditions shall be effective upon their publication on the Kraków Airport website and in the Participants' accounts of the Kraków Airport Loyalty Programme.
4. The Competition – for which the Terms and conditions are defined above by Kraków Airport – is not a game of chance, a raffle, parimutuel betting or promotion sweepstakes with a random outcome (through drawing) within the meaning of Article 2 of the Law on Games of Chance of 19 November 2009 (consolidated text: Journal of Laws Dz. U. of 2018, Item 165 as amended).
5. The Terms and conditions come into force on 20 December 2018.
